_____ **Registration:** Classes will be filled on a first come, first served basis. A \$35.00 **Non-refundable registration fee** **and** a \$35.00 **Non-refundable recital fee** are both due when you register for classes.

PLEASE DO NOT TURN IN THIS FORM WITHOUT BOTH FEES INCLUDED.

_____ **Tuition** is divided into nine equal payments. The payment remains the same regardless of absences, holidays, weather cancellations, and/or recital dates. Tuition is due on the 1st of each month & late after the 10th of the month regardless of weekends, cancellations, or holidays. **After the 10th an additional \$5.00 late fee must be paid.** After the 20th of the month, if the tuition & \$5.00 late fee has not been paid, the student will not be allowed to participate in class & will be counted absent. Your first payment is due the first week of class, & your last payment is due April 1st. **The person that signs the bottom of this paper is solely responsible for turning in all payments, regardless of divorced families/custody battles.**

_____ **Checks returned** to us by the bank for whatever reason will have a fee of \$30. This includes any check you write to Mooves for tuition, costumes, ads, merchandise, etc. If 2 of your checks are returned to us, we ask that you pay in cash the rest of the season. Failure to pay the money due will then be turned over to a collection agency.

_____ **Outstanding balances** should be paid for ASAP. You will not be allowed to purchase pictures, Ads, Mooves Merchandise, recital video or recital tickets until tuition, costume, & return check fees have been paid.

_____ **Costumes** range from \$50-\$90 each. A deposit of \$25.00 per class costume deposit is due September 1st & another deposit of \$25.00 per class is due October 1st. The remaining balance will be due in November. Any student withdrawing after costumes have been ordered will be responsible for paying the balance on his/her costume(s).

_____ **Children** are to remain inside the building at all times. Mooves cannot be responsible for unsupervised children. It is the parent's responsibility to have the student dressed & on time, as well as picked up promptly after class. Please monitor your children at all times and train them on how to respect our facility.

_____ **MOOVES NEWS** is issued monthly, as well as other important literature. Please take the time to read all information sent home or emailed. Closings are listed in the Mooves News. **PLEASE MAKE SURE THE EMAIL YOU PROVIDED ON THIS FORM IS ONE YOU CHECK OFTEN.**

_____ **Attendance** is required in class as absences affect the entire class. Please call if your child cannot attend class. However, there are no excused absences. If your child is sick, has a field trip, or other school related activity & they don't attend class they will be counted absent & will not receive the perfect attendance award. Student must be in class for at least 10mins to be counted present. Students missing more than 9 classes (6 if on traveling troupe) will be excluded from performing in the recital. All students are expected to participate in class unless they have a written note explaining why they should observe. Mooves will observe the same holidays as the Lenoir County Public Schools for Thanksgiving, Christmas, and Easter vacations. Mooves will remain **OPEN** for teacher workdays unless otherwise stated in Mooves News.

_____ **Inclement Weather** may cancel classes. Announcements of closings will be on the answering machine, website, facebook, & when possible on the door. Make-up days and/or credits cannot be given.

_____ **Dress Rehearsals are MANDATORY.** If your child does not attend dress rehearsal they WILL NOT perform in the recital. (Emergency Hospital Visit or deaths in the family are the only exceptions)

_____ **Trying one class** to see if you like it, is acceptable. If you don't like it there will not be a charge, but if you do like it and you continue to attend the class you must pay for that month's tuition.

_____ **"Three Strikes you're out"** is our motto for discipline. If a student is called down three times for misbehaving or not following directions they will be sent from the class to sit in the office & wait for their parent the remainder of the class.

_____ I, the undersigned, assume all risk & acknowledge that participation in dance class could result in personal injury, or Covid-19 illness. However, in consideration of the training of my child(ren) and/or myself, I hold "Mooves Dance Studio" and its staff harmless from any claims, damages, & expenses should such an injury or illness occur.
